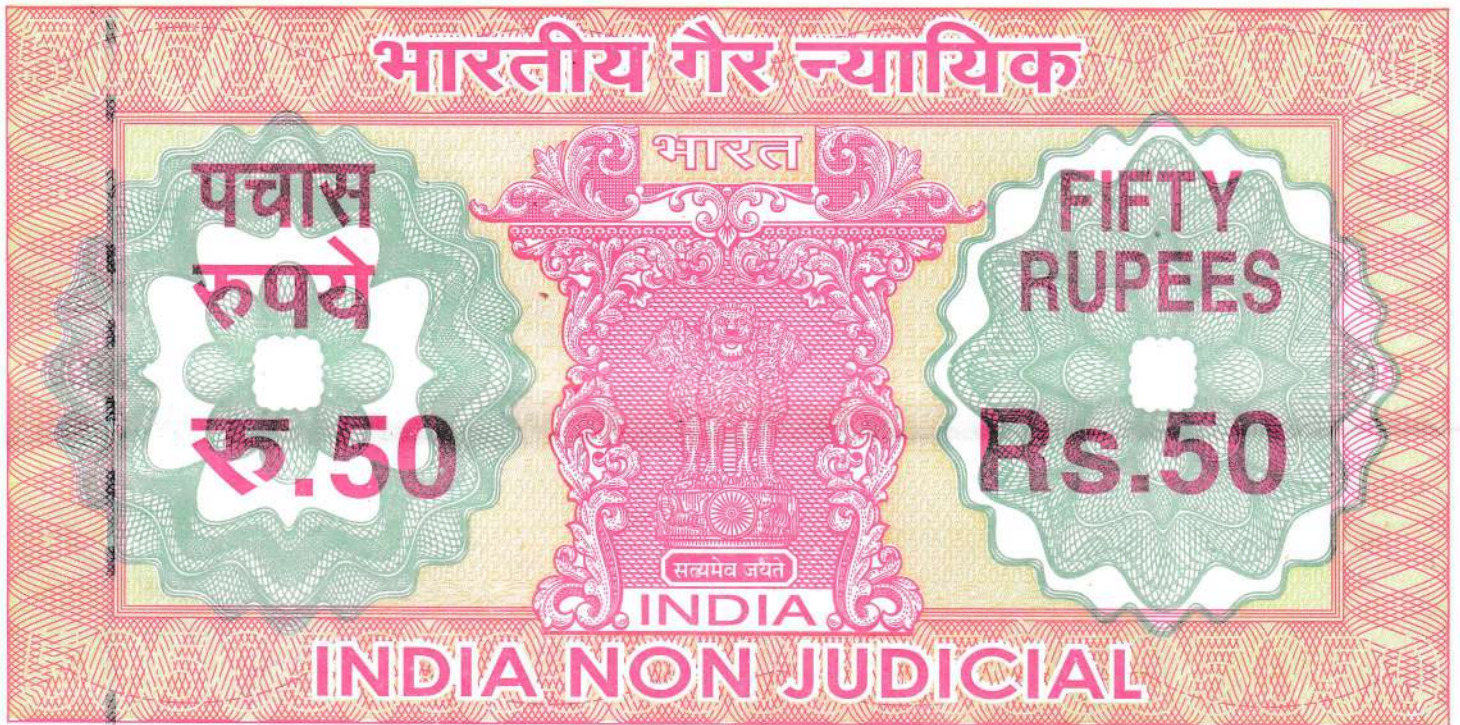

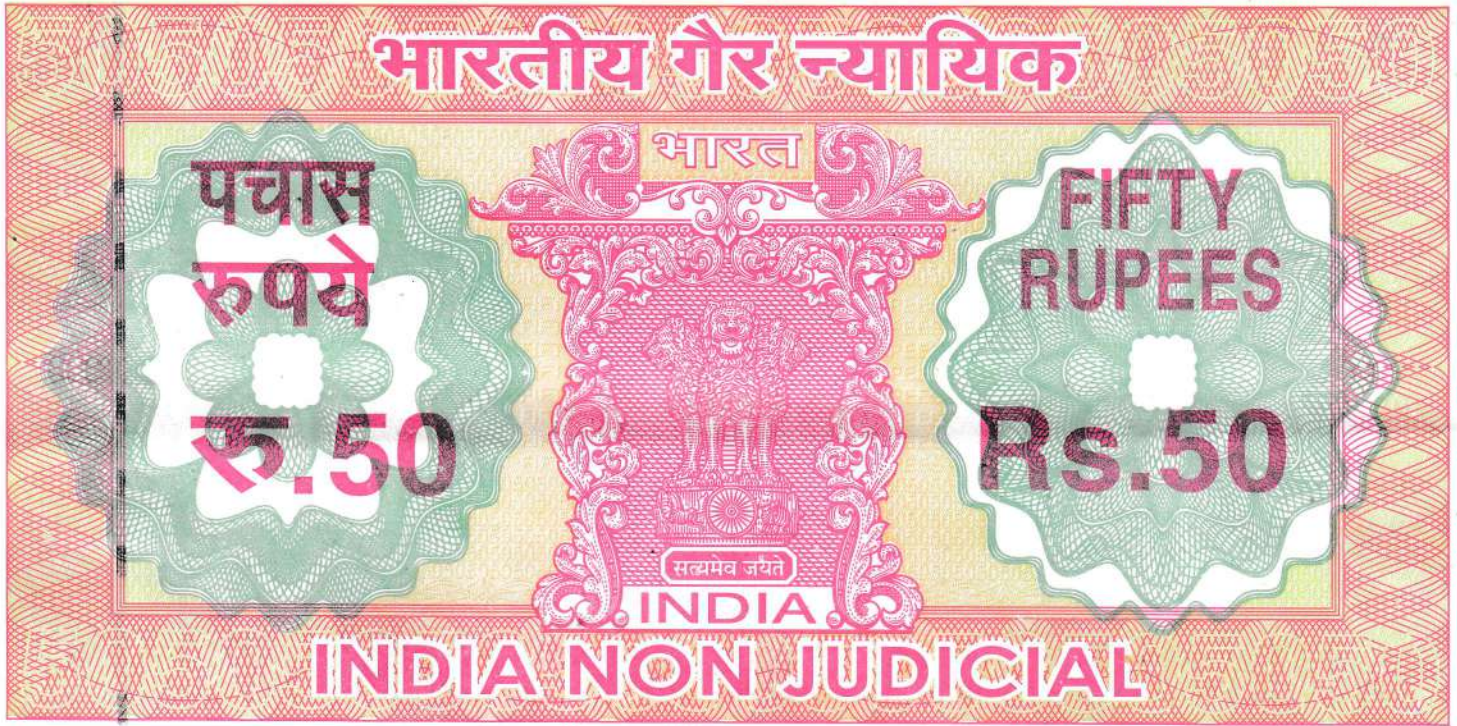

Any changes or additions to this Memorandum of Understanding must be submitted in writing and signed by both parties.

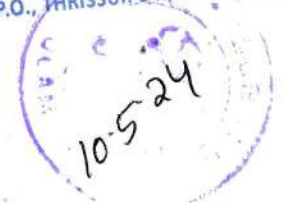

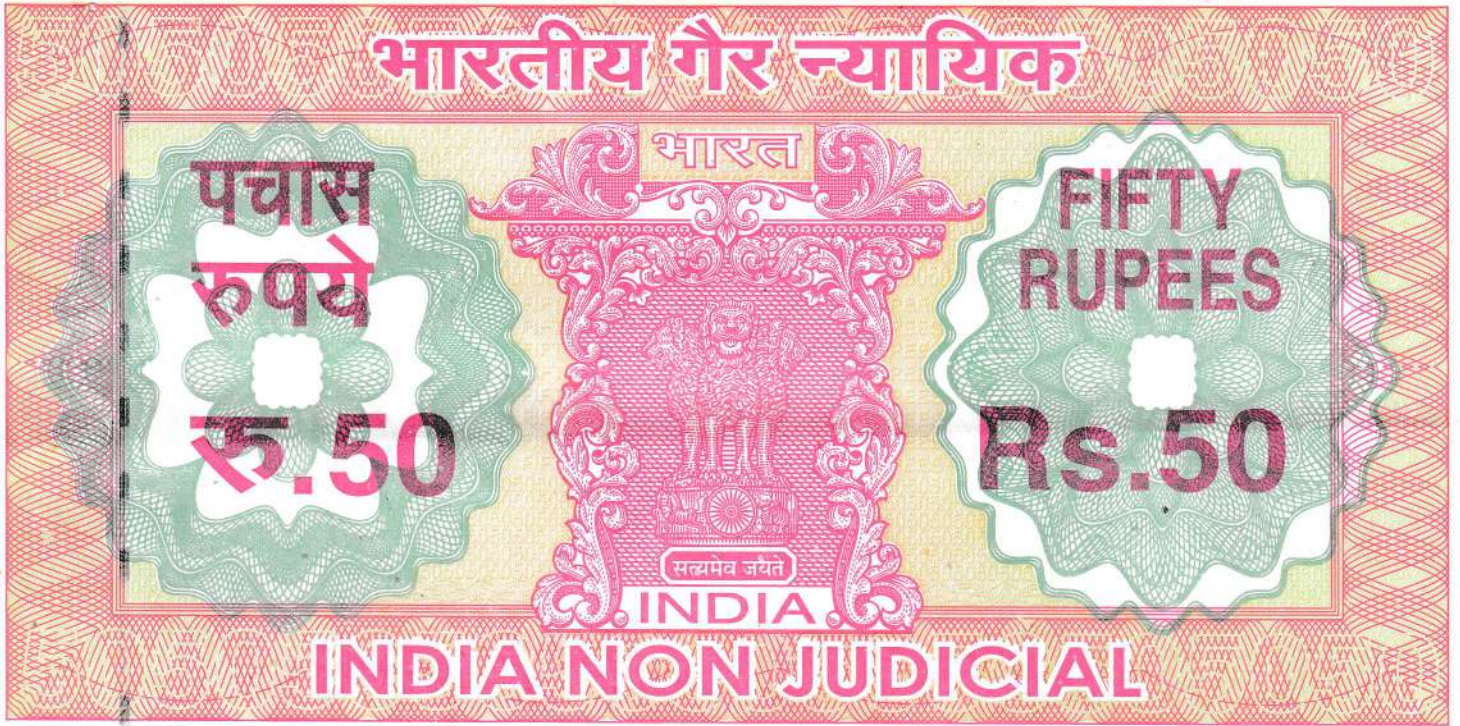
