This Memorandum of Understanding aims to set the terms of cooperation for organizing camps, including but not restricted to dental health camps, public awareness campaigns, and educational activities.

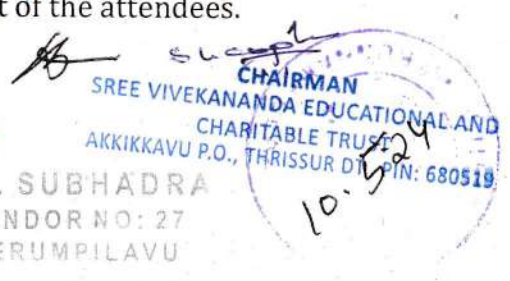
The purpose terms of the MoU are as follows:

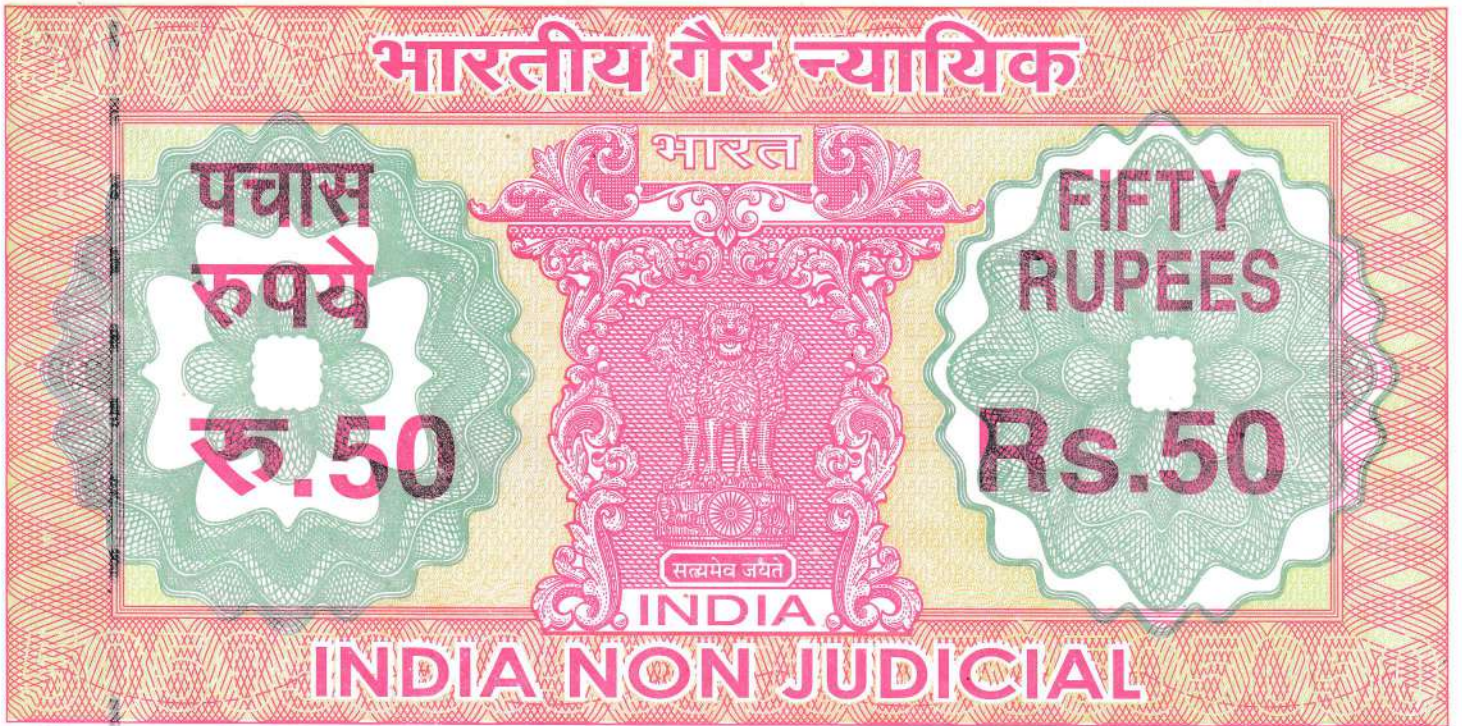
**1. Resource Sharing:**

Student, faculty, and community members were helped to promote oral hygiene and health awareness through collaborative planning, organizing, and execution of dental health camps and educational events.

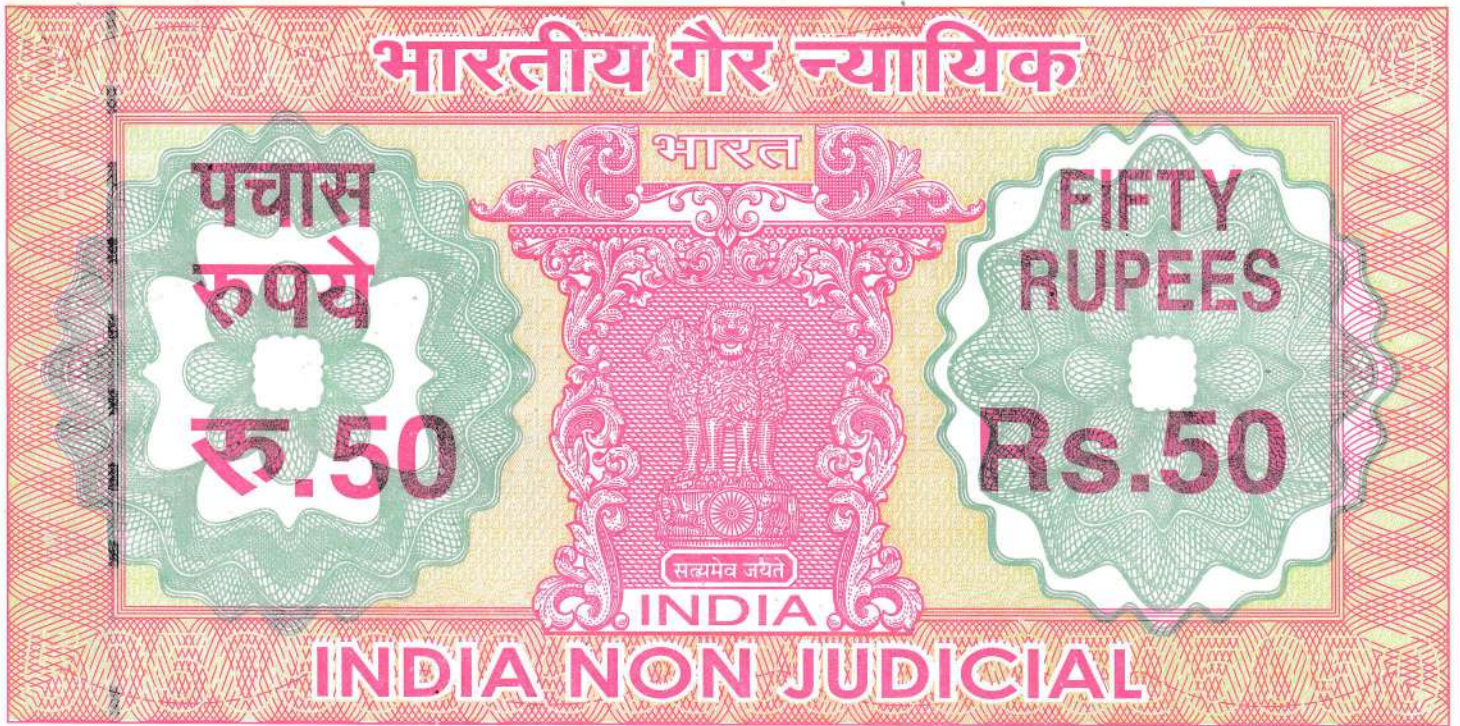
**3. Co-operation**

1. Confidentiality

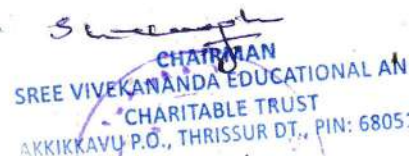
Regarding any private information given during the dental checkup, both parties shall preserve confidentiality.
